Photo by Michael Forsberg Photoshop's Basics There are two Photoshop components—the DAW (digital audio workstation) and the toolbox. The toolbox is the most intuitive component of Photoshop for beginning users because it is easy to understand and use. It is the interface for defining and arranging objects, layers, and settings. The DAW is less intuitive because it is the component used by Photoshop's expert users. The layers are the fundamental unit of Photoshop; they are arranged on a flat plane and blend with one another. In the toolbox, layers are found under the Layers palette. You can also drag them from other palettes in the toolbox to the Layers palette. Each layer has its own characteristics, and you can layer controls over it. You can edit these controls to change the way the layers behave. For example, you can reposition a layer in the Layers palette. Photo by Michael Forsberg The two most common ways to duplicate a layer are Super-Duplicate and Cloner. To Super-Duplicate a layer, choose Edit » Duplicate. When you do this, a new layer appears on top of the existing one, and the original layer is displayed in the Layers palette. Then, you can edit the original layer and drag it to where you want it. The Cloner creates a new layer that duplicates the original layer by merging the layer's attributes, such as color, texture, path, and other properties. You can use the handy eyedropper tool to select the attributes to be duplicated. You can find further instructions for using Photoshop's basic features under Learn Photoshop in the Toolbox. The Toolbox When you edit an image, you use Photoshop's toolbox to create and manipulate your image. The toolbox is subdivided into two categories—the Layers palette and the toolbox window, which you open by clicking the small, square button at the bottom of the Layers palette. The toolbox window enables you to use the included selections to edit your image. You can use these selections to: Define a rectangular area to mask; Select an object that you create in the layers palette; Create a new layer; Create a new adjustment layer; Open the Paths palette; Create and manipulate path effects; and Select a filter.

At the motion hearing, the City's counsel asked the trial court to order the demolition of the Wall, and to assess costs, including attorney's fees, against the Wall.[3] The City's counsel stated that the Wall was a "serious defect in the sidewalk," which causes "immediate danger." The trial court granted the City's motion and ordered the Wall to be demolished. *435 On appeal, Appellants contend that the City failed to prove that the Wall was a dangerous nuisance or that the Wall caused "immediate danger." In support of this argument, Appellants assert that the evidence shows only that the Wall may be a "dangerous defect" or a "dangerous condition," and not a dangerous nuisance. Appellants further argue that the City cannot seek to have the Wall demolished because the Wall was originally placed on private property. The law is clear that a governmental agency, such as the City, has the power to demolish a dangerous nuisance. See Code § 22.1-318 (defining "nuisance" as a "thing in the nature of a private or public injury"); Code § 22.1-309 (regarding "nuisance abatement"); Code § 22.1-323 (authorizing the county or municipal governing body to institute "an action or proceeding" for the purpose of abating a nuisance). Pursuant to Code § 22.1-318, a "dangerous nuisance" may be defined as a "nuisance... which is dangerous to life or limb, and which may be avoided only by the employment of special care and precaution...." Further, "[a] public or private corporation, utility or other person, his servants or employees, owning, operating, or conducting a public utility or street railway in the state, or a public corporation, public agency or public utility having authority or responsibility for such operation, street railway or facility, shall be liable for any personal injury or damage sustained by any person as a result of the dangerous and defective condition of any... facility of the corporation... involved...." Code § 54.1-3934(19) (providing liability for injuries caused by "[d]efective or unsafe conditions of sidewalks, curbs, or streets... which endanger... public safety"). Here, the evidence demonstrates that the Wall is a "dangerous nuisance," and "a dangerous defect," as defined by the statute.
